
8. I have never been paid at any time by the 1-800-Skyride syndicate and affiliates for their use of my copyrighted photos over the last many years.

9. I do not have the sufficiently ample resources to pursue my legal rights against the 1-800-Skyride syndicate.



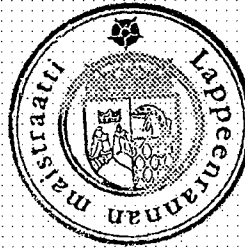

Hi Yvonne

I've got your contacts from freefall photographer Brent Finley. He told me you are the person taking care of that pictures used without an appropriate permission will be removed from various Skyride-related web sites. I've searched through 250 domains that are owned by Mr C. Quattrocchi either directly or indirectly via his enterprises. So far I've found 18 of my images used on at least 75 different sites, 1 to 9 images per site + all the subpages. All of those images are used without my permission nor I've received any compensation for it.

I'm a sole owner of the copyright of these images. Many of them have been used in heavily altered form which violates my legal rights as a photographer as well. There is even a logo created from one of the images. That logo is used on at least three websites. Most of the images would require to have a model release/s for this kind of publishing as well.

I expect that these images will be removed from the websites in question with no delay. I highly appreciate your co-operation.

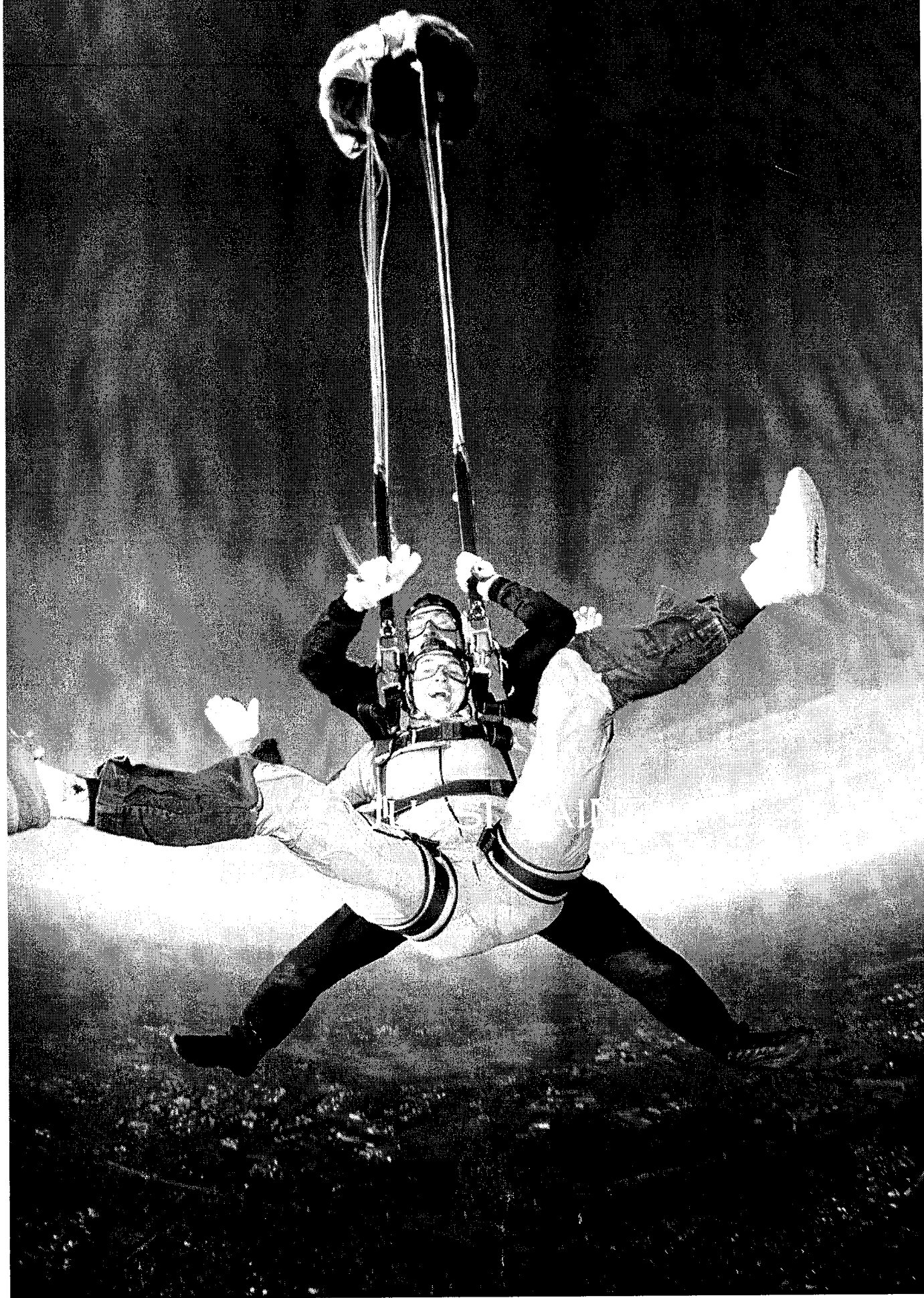

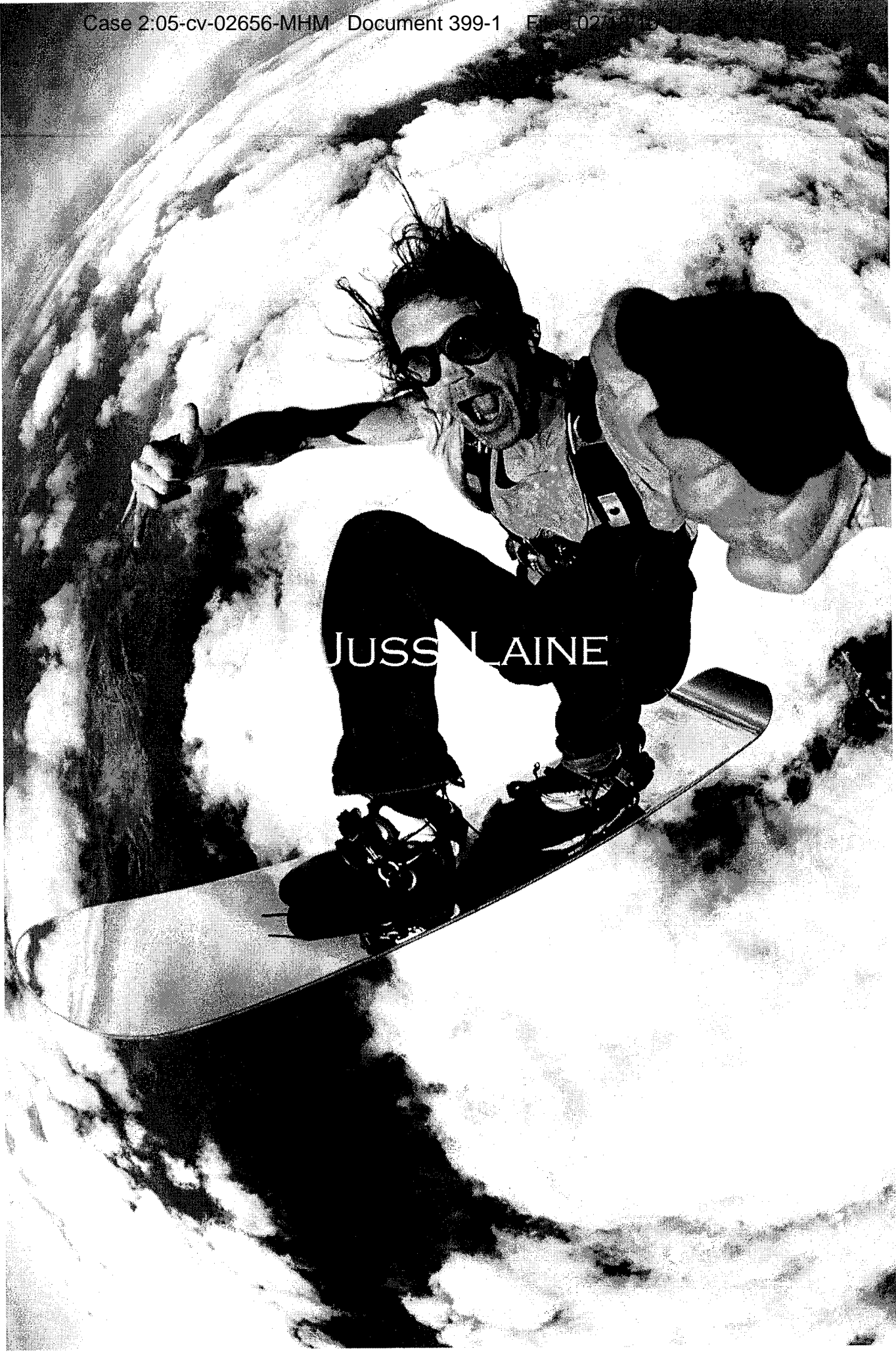

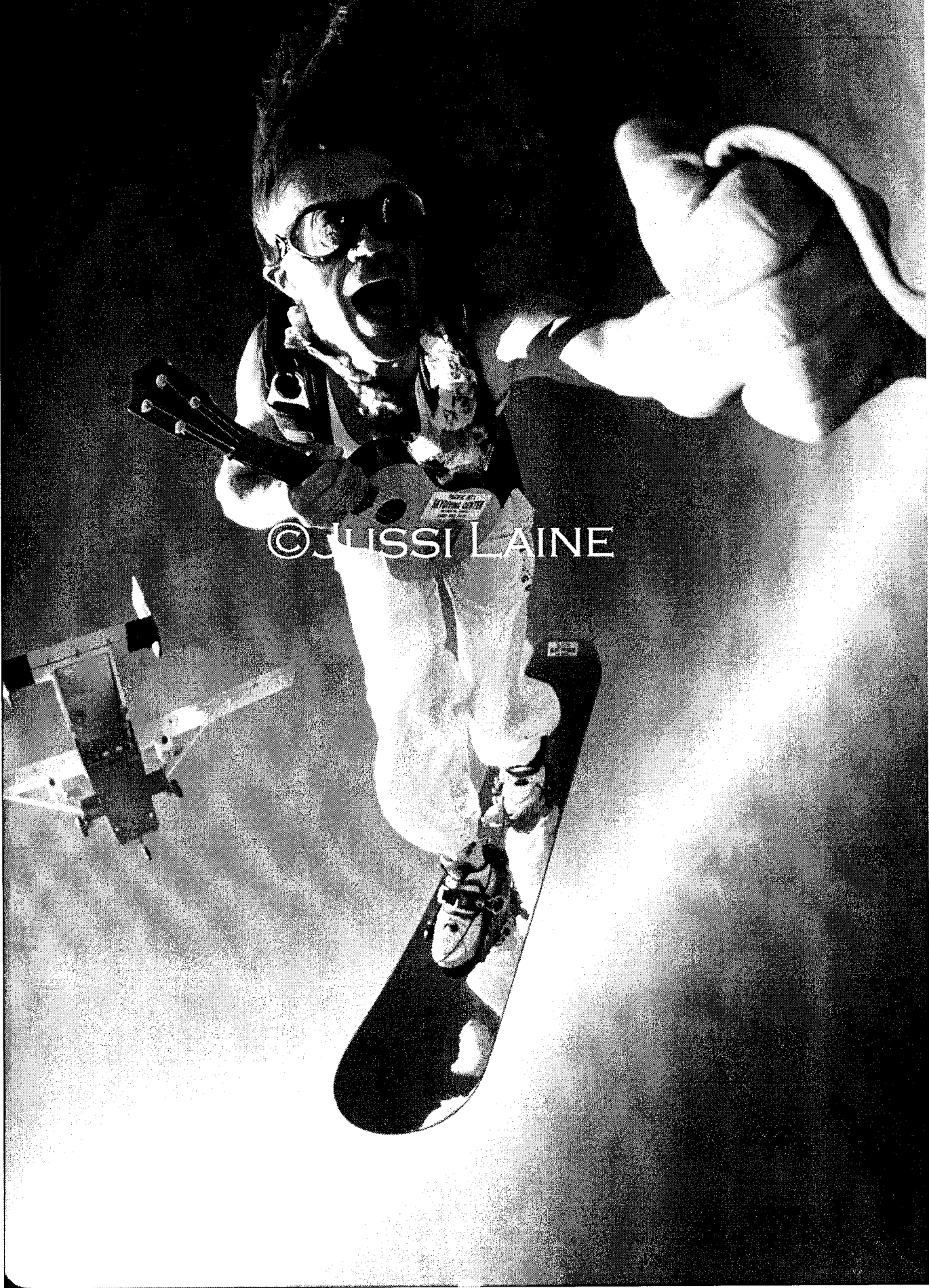
